## A VILLAGE FOLLY\*


(With Apologies to M.C. Escher and Luis Barragan)

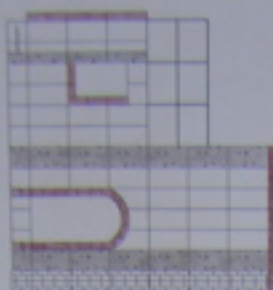

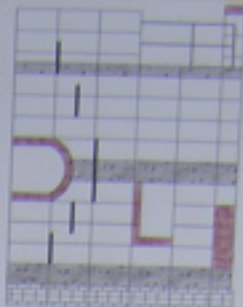

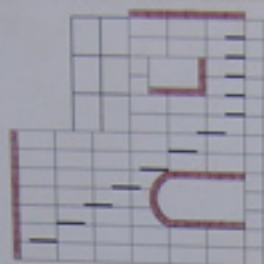
LEFT OUTSIDE ELEVATION

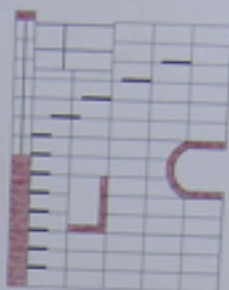
RIGHT OUTSIDE ELEVATION
